### 4. First Aid Measures

#### 5. Fire-Fighting Measures

Unusual Fire, Explosion and Reactivity Hazards: During a fire, irritating and possibly toxic gases may be generated by thermal decomposition or combustion.

In Case of Fire: Use dry chemical, foam or CO2 extinguishing media. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel from the area to prevent human exposure to fire, smoke, fumes or products of combustion. Prevent use of contaminated buildings, area, and equipment until decontaminated. Water runoff can cause environmental damage. If water is used to fight fire, dike and collect runoff.

#### 6. Accidental Release Measures

Personal precautions: Take appropriate protective measures. Clear area. Shut off source of

leak only under safe conditions. Extinguish sources of ignition nearby and downwind. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment. Environmental precautions: Do not discharge into the subsoil /soil. Do not dicharge into drains/surface waters/ groundwater. Contain contaminated water / firefighting water. Cleanup: Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. Spilled substance/product should be recovered and applied according to label rates whenever possible. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

### 7. Handling and Storage

Handling: No special measures necessary if stored and handled correctly. Ensure thorough ventilation of stores and work areas. When using do not eat, drink or smoke. Hands and/or face should be washed before breaks and at the end of the shift.

Storage: keep only in the original container in a cool, dry, well-ventilated place away from ignition sources, heat or flame. Product containers from physical damage. Product against contamination. The authority permits and storage regulations must be observed. Segregate from incompatible substances. Segregate from foods and animal feeds. Segregate from textiles and similar materials.

### 8. Exposure Controls/Personal Protection

Respiratory production: wear respiratory production if ventilation is inadequate. Wear a NIOSH - certified (or equivalent) TC23C Chemical /Mechanical type filter system to remove a combination of particles, gas and vapours. For situations where the airborne concentrations may exceed the level for which an air purifying respirator is effective, or where the levels are unknown or Immediately Dangerous to Life or Health(IDLH), use NIOSH - certified full facepiece pressure demand self- contained breathing apparatus (SCBA) or a full facepiece pressure demand supplied-air respirator (SAR) with escape provisions.

Hand production: Chemical resistant protective gloves, protective glove selection must be based on the user's assessment of the workplace hazards.

Eye protection: safety glasses with side-shields (frame goggles)

### 12. Ecological And Ecotoxicological Information

Effect on birds: low toxicity to birds, acute oral LD50 for Colinus virginianus is >2000 a.i.mg/kg.

Effect on fish: high toxicity to fish, acute 96 h LC50 for Oncorhynchus mykiss is 0.006 a.i.mg/L.

Effect on aquatic invertebrates: high toxicity to aquatic invertebrates, acute 48 hour EC50 for Daphnia magna is 0.016 a.i.mg/L.

Effect on algae: moderate toxicity to algae, acute 72 hour EC50 for Pseudokirchneriella subcapitata is> 0.843 a.i.mg/L.
